WHEREAS SJV Limited Partnership (the "Partnership") filed a Certificate of Limited Partnership (the "Certificate") on April 16, 2004 under registration number LP11030145;

AND WHEREAS the limited partners of the Partnership, being 1070259 Alberta Ltd., Venture Motorsports Corp. and Solitaire Investments Ltd., amalgamated with the holding corporation of each of these corporations, being 1103252 Alberta Ltd., and continued under the name 1116772 Alberta Ltd. ("111 Alberta");

AND WHEREAS 111 Alberta sold its entire limited partnership interest in the Partnership to Calpine Natural Gas, L.P.;

AND WHEREAS subsequent to the sale of its limited partnership interest, 111 Alberta amalgamated with its subsidiary SJV General Partner Corp., the general partner of the Partnership, and continued under the name 1145090 Alberta Ltd. ("114 Alberta");

AND WHEREAS 114 Alberta, the general partner of the Partnership, subsequently amalgamated with its holding corporation, being Calpine Natural Gas Limited ("CNGL");
